



SUGGESTIONS OF THE INSPECTION COMMITTEE:

- With the new recruitments it seems that either there were a smaller number of faculty members in the college previously or the college could not retain the faculty members. The college needs to make necessary arrangements to recruit new faculty members when new courses are opened or the intake capacity has been increased to strictly maintain proper SFR as per AICTE guidelines.
- The recruitment process should be complete within 2 months from the admission of the students. The institute should also take measures to retain faculty members since stability of the faculty members is good for academic environment as well as performance-based promotions.
- Since the institute will be offering Diploma in Artificial Intelligence and Machine Learning and Under Graduate in Artificial Intelligence and Data Science along with so many Diploma and B.Tech courses more computing facility is required to carry out the practical courses, irrespective of the departments. So, the institute should have many more high-power GPUs in the computer laboratories.
- All the computers of the laboratory where the practical classes of AI/ML or Data Science related courses will be carried out should have at least one 4GB GPU card attached with it.
- Names and brief profiles of the faculty members need to be uploaded on the institute's website along with various stages of Assistant Professor like Stage I/II/III mentioned.
- The Basic science related Laboratories of Physics/Chemistry/Language Lab etc. as well a Mechanical Workshop, Engineering Drawing as well as Basic Electrical and Basic Electronics should have sufficient space.
